Political Effects of Great Migration: Recap

- The Great Migration had political consequences, which ultimately affected the trajectory of politics in the U.S. South
- In essence, the first major political backlash from southern White elites had its antecedents in the Great migration
- Northward movement allowed Blacks to register and vote (for the most part), so Blacks became large enough in key cities and key states to often become kingmaker
- Precisely the same position they had been in before southern disfranchisement during the redemption period post Great Compromise of 1877

- Truman's advisors recommended an onslaught on segregation: Desegregate the military, Federal Employment Practices Commission (FEPC)

Truman and Civil Rights – 1948

- Harry Truman faced a monumental re-election campaign in 1948
- The Democratic Party had been in power for 16 years, and many people thought it was time for a change
- His opponent Thomas Dewey was a popular New York governor
- In addition, U.S. faced world legitimacy when promoting democracy and fighting communism abroad
- Truman's advisors recommended an onslaught on segregation: Desegregate the military, Federal Employment Practices Commission (FEPC)
- The advisors did not correctly predict the backlash that would ensue, giving rise to the Dixiecrat movement

- At this point, the Black electorate was volatile – they were still considered a swing constituency

- 1948 presidential election a very competitive election (Truman vs. Dewey). Gallup Poll had Dewey in fact winning 3 weeks before Election Day
- First election of 20th century where presidential politics contained serious debates about race politics
- At this point, the Black electorate was volatile – they were still considered a swing constituency
- Oscar De Priest was a Black Republican Congressman from Chicago between 1929 - 1935

- Truman promised African Americans that he would end discrimination, race prejudice, etc., in American life
- Humbert Humphrey (Senator from MN) successfully installed a strong Civil Rights plank in the Democratic platform
